for a Moving Out Permit: THIS IS NEEDED TO REMOVE YOU FROM THE Per Capita TAX ROLL. **(*Per capita bills are a per person tax. Township residents 18yrs. of age and older receive a PC bill. PC bills are paid by individuals **NOT** by the mortgage company).*

*** For a stamped paid receipt, you must Return BOTH taxpayer and remittance copy of the tax bill with a SELF ADDRESSED STAMPED ENVELOPE, OR a valid email address. State requires paid receipt for property tax rebate. *If you have an escrow account, please send your Real Estate Tax bill to your bank or mortgage company to avoid double payments.***
